- 1. Depository Units representing limited partner interests in American Real Estate Partners, L.P. ("AREP")
- 2. On August 8, 2007, AREP purchased from Icahn Management LP, CCI Onshore Corp. and CCI Offshore Corp. the general partnership interests in the management company and general partners (the "Fund Management Entities") of certain private investment funds managed by affiliates of Carl C. Icahn in exchange for, among other things, 8,632,679 Depository Units. Each of Icahn Management LP, CCI Onshore Corp. and CCI Offshore Corp. is indirectly wholly-owned by Mr. Icahn. In addition, Icahn Management LP, CCI Onshore Corp. and CCI Offshore Corp. will be entitled to receive certain contingent earm-out payments to be made in additional Depository Units over a five-year period based on AREP's achieving specified net after-tax earnings from the Fund Management Entities. The right to receive Depository Units pursuant to such earn-out right became fixed and irrevocable on August 8, 2007.
